### *Instructor's Certification Requirements*

**Mission Statement:** It is our intention to train practitioners of Touching the Light in such a way that they have a complete and working knowledge of the entire Etheric anatomy, a command of the process and an understanding of how, when appropriately applied, this modality will assist in healing not only the body, but the mind, the spirit and even the life experiences of their clients. Our students will also be given a full range of life skills awareness that they may apply in their own lives and their interactions with future clients.

**What We Offer:** Certification of practitioner's and instructors with complete instruction and training as well as permission upon certification to practice and or teach this modality fully and confidently to the general public. We also offer mentorships and hands on experience with a full range of examples of common and unusual situations that may arise with this type of procedure.

#### **Requirements for Practitioners:**

1. Completion of all requirements and payment in full of all tuition per agreed contract
2. Certification for Practitioners will be given upon satisfactory completion of all modules after the student has demonstrated compliance with all requirements and comprehension and application of all processes.
3. The range of courses will include not only teachings of this process, but also of the Etheric anatomy, energy system, accessing multi-dimensional realities, accessing higher awareness and states of consciousness, transmutation of energy and matter, self awareness and inner growth techniques, business structure and management, Techniques for expansion of awareness and understanding and management of emotions. Module content may be changed or adjusted without notice to include the most cutting edge information possible.
4. All candidates for status of practitioner **MUST COMPLETE** the full range of modules offered in order to receive certification. In the event one module is missed, it can be made up at any of our offered dates and locations within **ONE YEAR**. Graduation will commence once all modules are completed and the practitioner presents acceptable written examination and hands on session evaluations. In the event more than one module is missed, the situation will be evaluated and a final decision of whether or not the student may proceed will be made. This decision will be solely at the discretion of Dr. Meg and or her representatives. If the student elects to drop out or discontinue training all remaining tuitions must be paid in full per our contract. All fees and tuition must be paid by the agreed dates or certification will not be given.
5. Students must fulfill the required number of 30 hours of hands on practical application in the form of documented sessions with others outside of class opportunities and will be supervised by our staff and qualified instructors in training. During training, students may not charge for these practice sessions.

Records in the form given by our staff must be kept for each session to verify completion and to give the mentors and our staff a comprehensive view of the progress of our students. Each student will be assigned a mentor who will generally be an instructor in training who has full knowledge of the process and all its applications.

7. Each student will complete long distance sessions, info and details to be provided by our staff  
Students are expected to interact with our instructor students if any as it is part of the instructor student's requirements to learn to mentor students for any assistance they need as well as regular conversations either via phone or email outside of class.
8. Those certified by us may choose to participate in our practitioner's database on our web site so that those seeking our assistance can choose someone in their area if needed. Listing available upon certification for a nominal set up and publishing fee to be listed on the website pages. Pages are listed by certification level.

### **Practitioner's Level II Requirements**

1. Completion of all requirements and payment in full of all tuition per agreed contract
2. All of the Practitioner's Level One requirements PLUS:
3. Three Class Modules as described in the Practitioner's Level II Syllabus

### **Instructor's Certification Requirements**

All of the Practitioner's Level One and Two requirements PLUS:

- Completion of all requirements and payment in full of all tuition per agreed contract
- Candidates for the Instructors Level of Touching the light must have graduated with an excellence of competence and understanding of the practitioner's level one and two certifications.
- Each instructor is required to mentor at least three practitioner's level one students for one year with weekly calls either in person or on the phone. Email may be acceptable upon approval but not considered as an exclusive form of communication.
- Candidates for instructor must attend one year of practitioner one classes as student instructors under the supervision of Dr Meg and or her representatives/staff. In case of emergency or interfering issues or conflicts, Instructor students may be asked to hold class on behalf of Dr. Meg. In the event this happens, Instructor students must be fully willing, competent and aware of all subjects to be covered in class.
- Instructor's candidates must prove proficiency of all levels of application and understanding the Touching the Light process. All evaluation of this will be practical via teaching modules and hands on proficiency as well as working with level one and two students.
- Instructor students are expected to participate as advisor's to students as needed as well as setting up and participating in individual meetings with each student one on one to assist, answer questions, help with the processes that class is learning or whatever else the students need relevant to our program. It is our feeling that Instructor students will learn far more by doing rather than being taught separately, away from the other classes. Every participant has their questions, concerns, challenges, perceptions, in fact anything can come up. Instructor students have more opportunity to learn by experience than by being required to learn by written materials or being instructed outside of class so are expected to maintain current awareness with all class information and processes.
- Instructor Graduation is subject to evaluation and approval by Dr. Meg that the candidate is prepared to be a Touching the light Instructor in every aspect of the position. If at any time the student or Dr. Meg feels that more time is required for the instructor Candidate to be fully ready to teach Touching the light solo, class participation time will be extended to a reasonable amount of time at no extra charge up to one year.
